

The Council of the City of Grants Pass met in regular session on the above date with Mayor Fowler presiding. The following Councilors were present: Anderson, Eames, Flaming, Lindsay, Riker and Roler. Also present and representing the City were City Manager Cubic, City Attorney Bartholomew, Finance Director Meredith, Public Safety Director Landis, Parks & Community Development Director Glover, Public Works Director Canady and City Recorder Frerk. Absent: Councilor Lovelace.

Mayor Fowler opened the meeting and led the invocation followed by the Pledge of Allegiance.

#### 1. COMMITTEE LIAISON REPORTS

Councilor Eames reported on the Collaborative Economic Development Committee meeting. They had a nice GIS presentation. During the course of the meeting the group discussed what the objectives and responsibilities of the committee are. They seem to be having an identity crisis. Councilor Eames suggested that City Manager Cubic attend a meeting and give the committee direction. He also reported that the Urban Area Planning Commission approved the nine-lot Dutch Henry Subdivision off Kellenbeck Avenue, and 16 items of amendments in the Development Code – correcting errors.

Councilor Roler reported that he and Councilor Riker have been sitting in on the Josephine County Fairgrounds Board master plan meetings. The board was under the misconception that the City is having something done in the Urban Renewal Area right now, which has since been cleared up. They are talking about access points for the fairgrounds and they don't want to get it wrong and then have to go back and make changes in the future. They are looking to put together a Request for Proposal for someone to create the master plan.

Councilor Riker reported on three items that were approved at the Solid Waste Agency meeting. They approved funding for Community Service Officers to go out for solid waste pickup, graffiti, etc. Environmental Health also got funding for the coming year. And they approved funding for Josephine County Parks, which organizes and sponsors the river cleanup. They are expecting 200 volunteers and will have a little party afterward.


