

— The Council of the City of Grants Pass met in regular session on the above date with Mayor Fowler presiding. The following Councilors were present: Eames, Flaming, Lindsay, Lovelace, Riker and Roler. Also present and representing the City were City Manager Cubic, City Attorney Bartholomew, Finance Director Meredith, Deputy Chief Hamilton, Parks & Community Development Director Glover, Assistant Public Works Director Elliott and City Recorder Frerk. Absent: Councilor Anderson, Public Safety Director Landis and Public Works Director Canady.

— Councilor Lovelace reported that the Urban Tree Advisory Committee has been looking over amendments to Articles 23 and 25 of the Development Code, making sure the trees that are planted in Grants Pass remain healthy and survive. 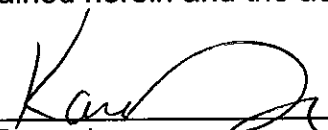
