**CRITERIA FOR APPROVAL:** The Historical Buildings & Sites Commission will provide a recommendation to the City Council. After the Historical Buildings & Sites Commission makes its recommendation, the City Council will hold a separately noticed public hearing to consider the application and the Historical Buildings & Sites Commission’s recommendation and make a decision on the application. The Historical Buildings & Sites Commission recommendation and the City Council decision will be based on the criteria in Section 13.441 of the City of Grants Pass Development Code (and/or Comprehensive Plan). The City Council may approve, approve with conditions, or deny the request based on the applicable criteria.

**OBTAINING MORE INFORMATION:** Copies of the application, all documents and evidence submitted by or on behalf of the applicant and the applicable criteria are available for inspection at no cost at the Community Development Department. Copies may be obtained for a reasonable cost. The Community Development Department is located in Room 202 of the City of Grants Pass Municipal Building. A copy of the staff report will be available at least seven days prior to the hearing. The agenda and packet items are typically available on the city’s website the Friday before the hearing.

**COMMENTING ON THE PROPOSAL:** The hearing will be subject to the Quasi-Judicial Hearing guidelines in Article 8 of the Development Code. At the hearing, the Historical Buildings & Sites Commission will take oral testimony concerning this proposal. Written testimony may be presented at the hearing, or may be submitted to the Community Development Department by 5:00 pm on the date of the hearing. Prior to the close of the initial evidentiary hearing, any party may request an opportunity to present additional evidence or testimony regarding the proposal. The review body shall grant such request by continuing the public hearing or by leaving the record open for additional written evidence or testimony. Failure to raise an issue in the hearing, in person or by letter, or failure to provide statements or evidence sufficient to afford the decision maker an opportunity to respond to the issue precludes an appeal based on that issue.
